

SCC- Training according to document 017/018

For this purpose you can choose from our dates in the area of SCC online preparation. The dates for the exam doc. 017 and doc. 018 are available. You can take the exam within a period of up to 4 weeks after the webinar.

Examination Requirement:


In advance of the examination, it is mandatory to obtain evidence that is recognized as admission to the examination by our person certification body. Please read the information in the appendix for the submission of possible proofs.



Our SCC training courses are offered at our seminar location at the AS Bauer Academy in Marl, as well as on request as in-house training and as webinars. We also offer SCC training in foreign languages upon request.



The examinations, which take place after the SCC training courses, are carried out by a personal certification body accredited by the DAkkS and cooperating with us and are valid for 5 years.



You have the choice between trainings/examinations for operational managers according to SCC document 017 and operational employees according to SCC document 018.

Important notes

- › If you book an in-house training/examination, costs for travel time and kilometers may be incurred in addition to the daily flat rate, depending on the distance.
- › For personal identification, a valid ID card must be presented on the day of the examination.
- › Existing safety passport must be brought to the training, if not available, reissue will be done by AS Bauer.
- › A current passport photo is required for the reissue of the safety passport.

SCC- training and examination according to Doc 017/018

Examination requirements:

For admission to the test, one of the following points must be fulfilled according to the current normative document.

- a. Proof of completed vocational training in accordance with the Vocational Training Act (BBlG); the participant has a vocational training qualification in accordance with the Vocational Training Act (BBlG), e.g. skilled worker's certificate, master craftsman's certificate, diploma certificate.
- b. Proof of completed vocational training abroad plus employer's confirmation of at least 1 year of professional experience in Germany; the participant has a foreign vocational training qualification, e.g. skilled worker's certificate, master craftsman's certificate, diploma certificate and has at least 1 year of professional experience in Germany confirmed by the employer.
- c. Confirmation from the employer of at least 3 years of work experience in Germany in a state-recognized training occupation; the participant does not have a vocational training qualification (domestic / foreign), but can provide evidence of at least 3 years of work experience in Germany in a state-recognized training occupation from the employer.
- d. Still valid SHE training including examination according to Doc. 016; the participant can prove a still valid SHE training including examination by a SHE examination certificate according to Doc. 016. The qualification as a specialist for occupational safety of the lecturer/examiner must be proven and attached to the SHE examination certificate according to Doc.016.
- e. Still valid SHE examination according to Doc. 017 / 018; the participant can prove a still valid SHE examination by a SHE examination certificate according to Doc. 017 / 018.
- f. Proof of substitute training (with at least 24 hours of instruction). It must be ensured that the participant has competence in German occupational health and safety, i.e. the substitute training can be carried out by occupational safety specialists or accident insurance institutions (UVT) or by recognized training providers in the SHE sector. Their instructors must demonstrate competence in German occupational health and safety.



Our SCC training courses are offered at our seminar location at the AS Bauer Academy in Marl, Germany, as well as in-house training upon request. We also offer SCC training in foreign languages on request.



The examinations, which take place after the SCC training courses, are carried out by a personal certification body accredited by the DAkKS and cooperating with us. The certificate is valid for 5 years.



You have the choice between training/examination for operational managers with personnel responsibility according to SCC document 017 and operational employees according to SCC document 018.
